UNDERSTANDINGS & RESPONSIBILITIES:

The land costs for the trip are shown in the table above. "Sharing" is the cost of each of two persons sharing a single room/tent. "Single" is the cost of a single person solely occupying a room/tent. The land price for the main Nepal Tiger Safari is based upon a minimum of 8 paying participants and will increase to \$7940 per person sharing if there are fewer, and \$9,990 as a single. The land prices for the pretour and posttour to India and Bhutan are based on a minimum of 2 persons. The land costs are exactly as described in EWT's itinerary, "The Land of Shere Khan," published May 10, 2023. These land costs include accommodations, meals, private transfers, organized sightseeing and gameviewing plus other activities as described in the day-by-day description. The costs include all taxes and fees and local, professional guides joining the trip at each venue (city). The costs for the main Nepal Tiger Safari also include guiding by tiger expert, Hasan Rahman, and hosting by EWT's Elizabeth Heck throughout the entire trip. The costs exclude all air fare, including air fare that is needed for pre- and posttour, which is dynamic and is only guaranteed when purchased. As of May 10, 2023, the air fare for Nepal was \$435 per person in economy and in India, \$360 in economy. Air fare needed between India, Nepal and Bhutan can likely be bundled into your international air fare. Anything not specifically mentioned in the itinerary is not included: Such items include but are not limited to tipping, some meals, most beverages, the costs of obtaining requisite inoculations and documentation, and any items of a personal nature like souvenirs and gear.

All payments to EWT are nonrefundable. Deposits are accepted by credit card without surcharge, but all subsequent credit card payments will be surcharged 4%. Final payment is due before December 19, 2023, and is nonrefundable.
